OR THE DISTRICT OF COLUMBIA WHO ARE 18 YEARS OF AGE OR OLDER.

NO PURCHASE NECESSARY TO ENTER OR CLAIM PRIZE. Purchase Will Not Improve Chances Of Winning.

1. **ELIGIBILITY:** Open only to legal residents of the 50 United States or the District of Columbia who are 18 years of age or older at time of entry. Employees, officers, directors and agents of Ocean Spray Cranberries, Inc. Upon submission of your entry, you will receive one entry into the Contest. You may enter as often as you wish, but each entry must be a different recipe. Entrants' recipes will be reviewed by Sponsor for compliance with these Official Rules. Sponsor reserves the right in its sole discretion to decide if an entry is appropriate, and may disqualify any entry at any time in the event it is determined, in the Sponsor's sole discretion that the entry is not appropriate, or, that the entrant has not complied with these Official Rules.
